FAREWELL TO ARIANE DELUZ

We started the New Year with the sad news of the fall of a Big Mande Tree, Ariane Deluz, one of our founding and most devoted members. Ariane passed away on January 16, 2010 in Lausanne, Switzerland, where she was born. She was truly a great MANSA scholar and very generous with her time and energies, serving as co-editor of the *Mande Studies* journal from its inception in 1998, and regularly attending MANSA events at both the ASA and our international conferences.

Ariane studied under George Balandier and Claude Lévi-Strauss. She was initially paired with Claude Meillassoux in the Guro ethnographic study. She was a researcher at the CNRS and a member of the Laboratoire d'anthropologie sociale of the Collège de France. Many of us who knew Ariane associate her with the Guro, a southern Mande group mostly found in Côte d'Ivoire where she produced both ethnographic literature and films. Ariane was, however, a global anthropologist. She traveled and worked outside the Mande world and Africa. For example, she wrote about, and in 1971 co-directed the production of an ethnographic film on the Embera in Colombia, South America. Ariane's interests included psychological and

medical anthropology and she was a pioneer in gender studies in Africa.

Ariane Deluz served as Secretary General of the Société des Africanistes (1990-1994) and President of AFA (Association Française des Anthropologues) from 1996 to 1999. She published extensively. An autobiography of Ariane can be found in an article entitled "Parenté symbolique et profondeur historique" *Journal des Anthropologues*, n° 64-65, 1996, pp.177-188 at <http://www.afa.msh-paris.fr/deluz.html>

notre revue dès son début en 1998, et assista régulièrement aux événements du MANSa aux conférences des Études Africaines et à nos conférences internationales. Elle fût l'étudiante de Georges Balandier et de Claude Lévi-Strauss. Elle fût d'abord associée à Claude Meillassoux dans l'étude des Gouro. Ariane fût chercheur au CNRS et membre du Laboratoire d'anthropologie sociale du Collège de France. Beaucoup d'entre nous associent Ariane aux Gouro, un groupe sud-Mandé se trouvant principalement en Côte d'Ivoire sur lesquels elle a produit des films et de la littérature ethnographique. Ariane a cependant été un anthropologue du monde. Elle a voyagé et travaillé à l'extérieur du monde Mandé et de l'Afrique. Par exemple, elle a écrit sur et en 1971, co-dirigé la production d'un film ethnographique sur les Embera en Colombie, en Amérique du Sud. Les intérêts Ariane incluaient l'anthropologie psychologique et l'anthropologie médicale et elle a été pionnière dans les études de genre en Afrique. Ariane a été secrétaire générale de la Société des africanistes (1990-1994), présidente de l'AFA (Association Française des Anthropologues) de 1996 à 1999. Elle a largement publié. Une autobiographie d'Ariane se trouve dans un article intitulé «Parenté et symbolique Profondeur historique" *Journal des Anthropologues*, n ° 64-65, 1996, pp. 177-188 à <http://www.afa.msh-paris.fr/deluz.html>. MANSA BUSINESS

Treasurer's Report

Of the 324 members in our database, 79 (24%) of our dues-paying members are currently up to date on their dues. Of our current members, 100 are sponsored colleagues, 15 are sponsored institutions, 23 are sponsors, 44 are regular members, and 12 are students. Of the 324 members (this does not include the 65 names in the database that have either dropped out of MANSA or have not paid dues since 2007), 62 (19%) are late in paying their 2010 dues and 73 (23%) have not paid dues since 2008.

MANSA membership extends across 31 countries (including Senegal, The Gambia, Sierra Leone, Guinea, Guinea-Bissau, Mali, Burkina Faso, Côte d'Ivoire, Nigeria, and Zimbabwe in Africa). 37% of our membership resides in the US, Canada, or South America (Brazil) and 27% in the greater Euro-Scandinavian region, with 1 member in Japan and 1 in Australia.

Mande Studies Journal Update

MANSA By-Laws Amendments and Officer Elections 2010

Survey Results

Last Fall, we sent an online survey to all 276 active members with email addresses to gather input on some of the central questions to be addressed in revising our bylaws. 73 members responded; a return rate of 26%, a significant response level. We thank everyone who took the time to respond to our survey.

One major potential change to our bylaws that was proposed by several of our most senior members was to replace our current configuration of Officers with one similar to that of the ASA and many other organizations where the election of a Vice-President is replaced with the election of a President-Elect. The idea would be to ensure continuity in the management of the organization without overburdening any particular individuals with too many years of responsibility.

Almost half (49%) of respondents agreed or strongly agreed with the President-Elect system. Based on this response, an amendment to change to the bylaws to a President-Elect system will be proposed to the membership.

The next important question is one of length of terms. Despite the fact that we voted in the now-distant past to change Officers' terms from 2-3 years, the change was never published in the official bylaws, so the current Officers are adhering to the 2-year term period (more about that later). The question now becomes, what should the term lengths be if the amendment for a President-Elect system is passed? Under this system, which provides for greater continuity, members no longer elect a Vice President and a President, but rather, members elect a President-Elect who automatically becomes President at the end of his/her first term.

Of the respondents who agreed or strongly agreed with the President-Elect system in the survey, the majority (24% of those surveyed) agreed or strongly agreed with a 2+2 year

system (2 years as President-Elect followed by 2 years as President). 15% of those surveyed agreed or strongly agreed to two 3-year terms (3+3) and only 6% agreed or strongly agreed with 4-year terms (4 years as President-Elect followed by 4 years as President). On the basis of these results, the proposed amendment to the bylaws for a President-Elect system will reflect the 2+2 year option.

In response to survey questions about the location and frequency of business meetings, 56% (41 out of 73 respondents) either agreed or strongly agreed to holding business meetings at the International MANSA meetings in addition to Annual ASA meetings, if there is sufficient business or reason to do so. The proposed amendment to the bylaws will be to allow for business meetings at the International MANSA conferences when there is sufficient business or reason to do so.

Unbelievably, two years have flown by and it is time to hold an election for President and Vice-President (or President-Elect) again. Unless there is substantial objection, the Officers propose to hold an electronic vote on the proposed changes to the bylaws, which will then permit us to hold the election electronically as well. Otherwise, we will be obliged to adhere to the time-honored system of voting on both the bylaws and the election at the business meeting during the ASA conference in San Francisco, Nov.18-21, 2010. 8th International Conference of Mande Studies: Ouagadougou, Bobo Dioulasso 2011

As mentioned in Newsletter #65, I [Kassim] was in Burkina Faso in early January 2010 to explore the possibility of holding our 8th International Conference there in the cities of Ouagadougou and Bobo Dioulasso. I have retained June 27 through July 1, 2011 as the conference date. One reason for picking these dates is due to the occurrence of the biannual

conference of Aegis (European African Studies) in Uppsala, Sweden from June 15-18, 2011. This will allow the European based MANSAdenw who plan to attend both conferences to do so. This date also takes into account the fact of the academic year ending much later in Europe than in North America. We are now one year away from the dates of the 8th International Conference. It is a good time to begin thinking about your paper and panel submissions. Please consider this message as the initial **Call for Paper and Panel Proposals**. *(Please print out and retain a copy of this for subsequent reference.)*

June 2010: Initial call for paper and panel proposals.

October 1, 2010: Panel chairs to issue general listserv notices of their panels and request submission of titles and abstracts (earlier notices welcome).

January 1, 2011: Membership renewals to Laura Arntson.

February 1, 2011: Submission of papers to Barbara Hoffman by West African colleagues residing in West Africa who wish to compete for funding to attend the conference. (This means Barbara Hoffman must receive the papers by this date.)

February 1, 2011: Submission of paper proposals to panel chair/organizers.

February 1, 2011: Deadline for submission to Kassim Kone of unattached paper titles & abstracts (i.e., papers not already part of a panel)

February 1, 2011: Conference registration and submission of fees to Laura Arntson.

February 15, 2011: Board/Jury members' evaluation and ranking of West African colleagues' papers to be returned to Barbara Hoffman.

March 1, 2011: West African colleagues notified of funding competition results by Barbara Hoffman.

March 11, 2011: Submission to Kassim Kone of all completed panels for the conference program.

8ème Conférence Internationale des Études Mandé Ouagadougou-Bobo-Dioulasso 2011

Comme mentionné dans le bulletin n ° 65, j'étais au Burkina Faso en début de Janvier 2010 pour explorer la possibilité de tenir notre 8ème Conférence internationale là-bas dans les villes de Ouagadougou et de Bobo Dioulasso. J'ai retenu les 27 Juin au 1er Juillet 2011 comme dates de la conférence. L'une des raisons pour le choix de ces dates est la tenue de la Conférence biennale de l'Aegis (Association Européenne des Études Africaines) à Uppsala, en Suède, du 15 au 18 juin Juin 2011. Cela permettra aux mansandew européens qui ont l'intention d'assister aux deux conférences de le faire. Member Activities/Achievements

David Conrad reports that the youth theater play *Sunjata Kamalenya*, written and directed by Christopher T. Parks, Director of Education at Princeton University's McCarter Theatre is expected to be ready for the stage in February 2011, after which it will begin touring the country. The script is partly based on the Djanka Tassej Condé version of the Sunjata Epic, and Conrad is consulting on the production. During the week of May 17-23, Parks and Conrad participated in the 2010 NEW VISIONS NEW VOICES program on "New Work for Young Audiences" at the Kennedy Center for the Performing Arts in Washington D.C. The McCarter Theater

production was one of seven works-in-progress by groups that included the Arden Theatre Company of Philadelphia; The Children's Theatre Company of Minneapolis; First Stage Children's Theater in Milwaukee; Seattle Children's Theatre; The Market Theatre in Johannesburg, South Africa, and Real TV in Melbourne, Australia. Daily rehearsals with equity actors and professional musicians were held throughout the week, with readings staged on the weekend. *Sunjata Kamalenya* is part of an experimental theater style being developed by Christopher Parks, in which children selected from the audience become actors in the play.
